## **DIRECTIONS to BERNIE'S PLACE DTF**

For those of you with GPS or who want to Google directions, the address is 16450 Lawrence Road, Escalon, CA 95320. ***The building entrance is actually around the corner on Arthur Road – look for the Bernie's Place DTF sign – and enter through the double gates.***

### **From the Bay Area**

- East on 580 to 205 (Tracy)
- Exit onto ramp to I-5 North
- Keep right to exit #461 to merge onto CA 120 East toward Manteca/Sonora
- Exit CA 99/CA 120 North toward Sonora/Sacramento
- Merge onto CA 120 East/CA 99 North
- Keep to right to exit CA 120 East/Yosemite Ave toward Sonora
- Turn right at CA 120/East Yosemite Avenue
- Turn left at Sexton Road
- Turn right at Arthur Road – pass Lawrence Road and enter double gates on left at the “Bernie's Place DTF” sign.

### **From Sacramento Area on I-5 South**

- Exit toward Downtown Stockton/CA 4 East. Keep right to merge onto CA 4 East
- Exit onto CA 4 East/CA 99 South toward CA 4 East/Fresno. Continue on CA 99 South toward Los Angeles
- **\*\***Exit CA 120/Yosemite Ave toward Sonora
- Turn left at East Yosemite Avenue
- Turn left at Sexton Road
- Turn right at Arthur Road – pass Lawrence Road and enter double gates on left at the “Bernie's Place DTF” sign.

### **From Sacramento Area on Hwy 99 South**

CA 99 South towards Los Angeles and follow above directions starting at the **\*\***.

### **From Southern California on I-5 North**

- Exit #461 to merge onto CA 120 East toward Manteca/Sonora
- Exit CA 99/CA 120 North toward Sonora/Sacramento
- Merge onto CA 120 East/CA 99 North
- Keep to right to exit CA 120 East/Yosemite Ave toward Sonora
- Turn right at CA 120/East Yosemite Avenue
- Turn left at Sexton Road
- Turn right at Arthur Road – pass Lawrence Road and enter double gates on left at the “Bernie's Place DTF” sign.

### **From Southern California on Hwy 99 North**

- Exit CA 120 East/Yosemite Ave toward Sonora
- Turn right at CA 120/East Yosemite Avenue
- Turn left at Sexton Road
- Turn right at Arthur Road – pass Lawrence Road and enter double gates on left at the “Bernie's Place DTF” sign.
